Enrollment

For enrollment of a student in Neosho Christian School to be complete, the following documents must be on file with the Superintendents office:

1. Immunization record showing that all state-required immunizations are current.
2. If a Pre-Kindergarten or Kindergarten student, a copy of the child's birth certificate.
3. Application for admission, approved by the Superintendent
4. Tuition agreement, signed by a parent/guardian responsible for the payment of the tuition.
5. If a transfer student, a request for transfer of student records, signed by the parent/guardian.
6. Payment of a minimum of ten percent of the annual tuition, non-refundable.
7. A child must be 4 years old as of July 31, of the year enrolled, to be eligible to enroll as a pre-kindergarten student, (unless special permission is obtained from the Superintendent).
8. A child must be 5 years old as of July 31, of the year enrolled, to be eligible to enroll as a pre-kindergarten student.
9. A child must be six years old as of July 31 of the year enrolled to be eligible to enroll as a first grade student, unless the child has successfully completed kindergarten at another school, not to include a home school.

School Hours and Calendar

Classes begin promptly at 8:15 a.m. each school day and dismiss at 3:00 p.m., with a lunch period of 25 minutes and recesses of 15 minutes. Parents will be notified of an deviation from this schedule. Supervision will be available beginning at 7:45 a.m.

The school calendar is adopted annually and consists of a minimum of 1,044 hours of classroom instruction. The calendar coincides as much as possible with calendars of surrounding public school districts for the convenience of families who have children attending Neosho Christian School and other children attending public school

Part time enrollment or attendance is not permitted without prior arrangements approved by the Superintendent. Parents are expected to encourage and assist their children to meet the required attendance policy, in order to reach their fullest potential as learners.

Dress Code

In keeping with our core values at Neosho Christian School, we employ a dress code to ensure modesty, respect, and safety. We believe we were created to glorify God and to offer our best to him in all we do (excellence). At Neosho Christian School, we desire that students honor others above themselves (respect) and not become a stumbling block for others (modesty).

“I therefore, a prisoner for the Lord, urge you to walk in a manner worthy of the calling to which you have been called, with all humility and gentleness, with patience, bearing with one another in love, eager to maintain the unity of the Spirit in the bond of peace.”
Ephesians 4:1-3

All students are required to dress modestly and appropriately at all times. Tank tops, see-through shirts or blouses, strapless/spaghetti straps, low necklines, and shirts with inappropriate advertisements (alcohol, tobacco, drugs, immodest pictures, etc.) are not permitted. Sleeveless shirts are allowed, but straps must be at least two inches wide.

Dresses and skirts must extend to the top of the knee. **All clothing must not be form fitting. Pants are permitted, however yoga pants, leggings, jeggings, and tights are defined as undergarments, therefore one’s top must extend to the top of the knee.** No clothing should contain holes.

Due to recess and P.E, students in Pre-K through 4th grade may wear knee length shorts up until October 1. For some physical education activities, knee length shorts may be allowed for students in 5th - 12th grade. Tattoos are not allowed. Boys are not allowed to wear earrings or studs in any part of their body. Boy’s hair length should not touch their collar, hair cannot be styled in a way to avoid this rule, and no man buns or pony tails allowed. Distracting hair color or styles are not allowed and hair color must be considered natural and appropriate for the student’s age. Facial hair is not permitted. Distracting headbands or accessories are not allowed except on Spirit Days. Girls may wear modest earrings or studs in ears only.

Students not adhering to the prescribed NCS dress code will be referred to the school superintendent. Parents will be contacted in cases of dress code violations. In the event of any questions regarding student attire, the decision of the Superintendent or his designee shall be deemed final.

Attendance Policy

Attendance Policies

Christ-Centered educational excellence is part of our mission at Neosho Christian School. Excellence is one of our core values and states: We believe we were created to glorify God and to offer our best to him in all we do. Offering one's best involves regular attendance and arriving to school and class on time. We further believe students should maintain a level of attendance that enables them to meet the academic requirements as learners. Parents and students hold the responsibility of school attendance and following the attendance policy.

Attendance requirements

1. All students are expected to attend school and assigned classes at all times when school is in session.
2. Parents or guardian are required to contact the office the morning the student is going to be absent for all or part of the day.
3. A student is considered absent unless excused for a school related activity such as (field trips, competitions, sports, visiting a college, etc). All other absences will not be considered excused.
4. When it is necessary for a student to miss several days, the parents or guardians are expected to contact the office in order for the student's work to be gathered.
5. A student exceeding 10 unexcused absences per semester will result in a the parent/guardian providing a written explanation of each absence and a meeting with the parents and the Superintendent to determine if the student should remain enrolled at NCS and/or should receive credit.

Tardy

1. A student is considered tardy unless there are unavoidable circumstances. The Superintendent determines unavoidable circumstances.
2. A student who arrives more than 10 minutes late to class will be considered tardy and absent.
3. Students will be given warnings for the first 4 tardies of each quarter. After the 4th tardy, the parent/guardian will be notified. Consequences for tardies are as follows:

1-4 Warning

5-6 After school detention (5th-12th grade)

7-8 In school suspension (5th- 12th grade)

Those that are often tardy negatively impact their academic progress, but also disrupt the learning environment of fellow students.

Field Trips

Throughout the school year, real-life learning situations will be available to students of Neosho Christian School. In such cases, parents will be notified in advance of travel to such events, and parents must give written approval for their children to travel to those events. In some cases, parents may be asked to volunteer as chaperones to assure adequate supervision of students. Field trips are counted as a school day. Field trips are considered a privilege, therefore students who are earning a D or F in any class will not be allowed to go on field trips. Those students will be required to stay at the school and work on assignments to help improve their grade. Students who are not eligible for the field trip and do not attend the study hall at the school will be counted absent. School conduct will also be a consideration when allowing students to attend field trips. If your child misses the field trip, it will be counted as an absence.

Testing

In addition to tests given by classroom teachers, students will take standardized tests to determine placement in certain subjects and/or to determine if adequate progress is being made in the subjects studied. The Stanford Achievement Test (SAT), a reputable nationally-named test, will be administered each spring by qualified personnel to determine the progress of Neosho Christian School Students. An entrance test may also be administered in the fall, to determine the academic level of teaching materials to be provided to students. During such periods, parents are asked to see that their children are free from as much stress as possible and that they get proper sleep the night(s) before the tests, along with a healthy breakfast so the students will be able to perform at their best.

Class Ranking

Although students will frequently be working at an individualized pace, all students will be assigned a traditional grade level. Children who are 4 years old as of July 31, of the year of enrollment in Neosho Christian School, will be classified as a pre-kindergarten student. Children who are 5 years old as of July 31, of the year of enrollment in Neosho Christian School, will be classified as a kindergarten student. Children who are 6 years old as of July 31, of the year of enrollment in Neosho Christian School, will be classified as a first grade student, if the student has completed kindergarten. As students are promoted at the end of any given school year, their class ranking will increase by one year.

Progress Reports

Teachers will provide a progress report to parents at least quarterly. In the event that a teacher feels it is necessary, special progress reports may be provided, or the teacher/parent may request a conference.

Change of Address or Contact Information

If the address of a student changes, notification of the new address should be given to NCS immediately to prevent sending student information to the wrong address. If the phone number of the student or parents (home or work) or emergency contact person changes, the new phone number should be provided to NCS immediately to avoid any delay in providing medical attention, should such attention be needed.

Privacy of Student Information

Student information, including information about the student's family, is considered confidential information and will not be provided to persons or organizations outside Neosho Christian School, unless written permission has been granted by the parent/guardian or a court order requiring such information has been served to NCS.

Visitors

Students are not allowed to bring visitors to class with them, unless prior approval has been obtained from the superintendent. Approval is normally granted only if the visitor is a prospective student who is interested in learning more about Neosho Christian School.

Any visitor to the school, including parents, must stop at the office and be issued an appropriate pass before proceeding to any area of the school.

Use of Students for Fund-raising Activities

Students are encouraged to show school pride by participating in fund-raising activities that have been approved by the administration. Care must be taken to avoid fund-raising activities that infringe on class time. Students must be dressed modestly and appropriately for all fund-raising activities and present a good image of NCS to the public. NCS shall not ask students to participate in fund-raising activities to benefit individuals or organizations other than Neosho Christian School. Students may not solicit money from or sell products or services to faculty and staff members during school day or on the school campus, except for NCS fund-raising activities.

Student Conduct

All students are expected to conduct themselves in a peaceful and obedient manner. They are to obey instruction of any teacher or the superintendent. Disobedience to school rules or instructions of any teacher or administrator will result in punishment that is appropriate for the offense.

Some offenses are considered serious offenses that may result in immediate suspension or expulsion. Some of those offenses are weapons possession, defiance, fighting, possession or use of illegal drugs or alcohol or drug paraphernalia, stealing, sexual harassment, racial slurs, or threats of violence. Bullying of any form will not be tolerated and should be reported to a teacher or administrator immediately. This list of serious offenses is not intended to be a complete list, and unlisted offenses may be considered serious.

No inappropriate physical contact, including all forms of public displays of affection (including but not limited to: holding hands, hugging, cuddling, and kissing.)

The presence on school property or at school activities of any apparel, jewelry, accessory, symbol, graffiti, gesture, games, cards, or manner of grooming which by virtue of its color, arrangement, trademark, or other attribute denotes membership in a group that advocates drug use, violence, or satanic involvement is forbidden.

Cell Phone/Electronic Device

Students at Neosho Christian School may have a cell phone in their possession with the following stipulations. All cell phones should be contained in a pocket or purse at all times and should not be seen during school. Once students arrive at school they are not to use the cell phone. If a call needs to be made, students are to go to the office to make a call. They may use the cell phone in the office or use the office phone. If a cell phone or other messaging device is in use during class time, it will be taken to the office and parents will be asked to pick it up. Electronic games on any device will not be allowed at school.

Disciplinary Action

Disciplinary actions that may result from misbehavior/conduct offenses are as follows:

- **In-class discipline** - Action appropriate to the offense, to include a warning, seating reassignment, in-class isolation, withholding of class privileges, contract with student, temporary removal from the classroom, conference with parent, referral to the superintendent.
- **Restitution** - Restitution for loss or damage caused, if loss or damage was accidental. Restitution and other appropriate disciplinary action, if the loss or damage was intentional.
- **Loss of privileges** - Denial of privileges or eligibility relating to the violation.
- **After School Detention** - Students will be detained from 3:00 to 4:00 pm.
- **In-school suspension** - Assignment to an area isolated from other students during the school day in a structured study environment.
- **Out-of-school suspension** - Removal from NCS for a set period of time. Students will not receive credit for missed work and are not allowed to be on campus during the suspension period. Out-of-school suspension must be assigned only by the superintendent.
- **Expulsion** - Permanent removal from NCS. Expulsion must be assigned only by the School Board. Prior to receiving disciplinary punishment, a student has the right to an explanation of the charges against him/her and an opportunity to present his/her response to the charges.

Closed Campus Regulations

Neosho Christian School has a closed campus policy. This means that when students arrive at the campus, they are free to leave the campus prior to regular dismissal time only if a phone call is received from a parent/guardian or other authorized person or the student is signed out by a parent/guardian or other authorized person.

Lunch Period

Students will bring lunch, or parents may bring lunch to students. All students will eat lunch in the cafeteria area, unless the teacher has arranged for a special event with the students.

Lunch times:

11:15 a.m.-11:40 a.m.: Grades Pre-K-4

11:50 a.m.-12:15 a.m.: Grades 5-12

Academic Duty

Students will plan their time so that they will be able to devote sufficient energy to their studies to ensure grades that reflect their true abilities. Semester averages will not be considered for eligibility purposes. Students must have a C average with no more than one D and no F's to be eligible for athletics at NCS. The eligibility list will be updated every quarter.

Grading Scale

- A-90-100%
- B-80-89%
- C-70-79%
- D-60-69%
- F-59% or below

Medications Policy

Non-prescription medications (over-the-counter medications) supplied by the parents will be administered by Neosho Christian School staff only if written instructions, with permission, have been given by a parent/guardian. Such medications must be in the original container with dosage instructions. Non-prescription medication so administered must be specifically formulated for the age of the child receiving the medication. If the dosage instructions do not specify a dosage for the age of the child receiving the medication, the staff will not administer the medication.

Prescription medications will be administered by Neosho Christian School staff with the following stipulations:

1. The prescription container must specify the name of the student receiving the medication.
2. The prescription container is the original container supplied by the doctor or pharmacy.
3. A parent/guardian has given a written request that the medication be administered by Neosho Christian School staff.

Release of Students to Non-designated Persons

Students will not be released into the custody of any person not designated on the enrollment application, unless permission has first been granted by a parent/guardian of record. If a parent has authorized another person to pick up his/her child, that parent should send a note to the teacher to prevent any delay in the release of the student to an authorized person.

Graduation Requirements

To be eligible to graduate and receive a diploma from Neosho Christian School, a student:

- Must complete entire senior year of attendance at Neosho Christian High School.****
- Must have paid all financial obligation to NCS.
- Must be in good standing at the end of the senior year.*
- Must have completed the minimum course requirements in grades nine through twelve as stated below:

*Must not be suspended or expelled by NCS or incarcerated or otherwise adjudicated guilty of a criminal offense by a civil or criminal court.

**Other electives may be substituted for Bible for students who enroll after their freshman year, with substitution limit of one unit of credit for each year attended in a different school. Students are required to have 4 units of Bible. Based on a seven-period day.

***Other electives may be substituted with the approval of the administration.

****Unless approved by Board of Education.

Graduation with Honors

- The valedictorian of the senior class shall be the student with the highest grade point average, based upon a 4.0 scale, with a minimum grade point average of 3.5+.
- The salutatorian of the senior class shall be the student with the second highest grade point average, based on a 4.0 scale, with a minimum grade point average of 3.0.
- In the event that two or more students are tied at the highest or second highest grade point average, co-valedictorians or co-salutatorians shall be named.

Student Acceptable Technology Use Policy

Recognizing the value of computer technology to enhance student development, Neosho Christian School is excited about integrating technology further into the classroom setting. NCS has as its mission and philosophy to provide an opportunity for the maximum development and optimal growth for the student.

It is the policy of our school to maintain a technological environment that promotes ethical and responsible behavior in all online network activities. Use of technology resources in a disruptive, inappropriate or illegal manner undermines the schools objectives and will not be tolerated. Students who accidentally access unacceptable material shall immediately notify appropriate school personnel (teacher or any administrator). This disclosure may serve as a defense against allegations that the user has intentionally violated this policy.

Unacceptable use of technology includes, but is not limited to:

- Allowing another person to use your password/user id to gain access to any school system including your own
- Sending, displaying, or storing inappropriate content to any location (or other device on school premises), such as: Offensive messages or pictures, sexting, possession of sexually explicit, vulgar, or violent material
- Threatening, harassing, insulting or attacking others (cyberbullying)
- Violating copyright laws
- Releasing personal information or false information about another person or yourself, including but not limited to: name, address, phone number, email address, social security number, account number, passwords and other items used for identification
- Damaging computers, computer systems or computer networks
- Trespassing in another's folders, work, files, or decrypting system or user passwords
- Employing the network for commercial or political purposes
- Crashing, attempting to crash network systems (district or other), or willful introduction of computer "viruses" or other disruptive/destructive programs into the district network or into external networks
- Using the network for any purpose or activity that is prohibited by federal, state, local laws, rules or regulations
- Attempting to join non-school owned/managed equipment to the school network
- Any faculty or staff member may moderate restrictions on student use (such as the amount of time online)
- Intentionally peeling off serial number, barcode, etc.

Mobile Device Acceptable Use Policy and Agreement

Neosho Christian School will provide mobile devices for 5th-12th grade students and it is an important and required part of our school's curriculum. At this time, mobile devices must remain on school grounds unless otherwise approved by an NCS staff member.

Terms of Student Usage Agreement

- Students acknowledge that any issued device is the property of Neosho Christian School. It is yours to use, but it is owned by the school. You will return the device to Neosho Christian School upon your withdrawal from the school, at the end of the school year or immediately upon the request of school staff. Failure to return the mobile device, for any reason, at the end of the school year or when withdrawing from Neosho Christian School will result in a \$300 charge. Students will not be issued a new mobile device until the fee is paid or the original mobile device is returned.
- Students will adhere to these terms each time the device is used, including when not on school grounds.
- Students will make available for inspection by any school staff any messages or files sent or received on their NCS issued device.
- Students will report to responsible school personnel any incidents of inappropriate electronic communications transmitted in any form using NCS owned technology.
- Students will not, in any way, deface the device or adhere stickers or other markings.
- Students will ensure their NCS issued device is placed in the charging cart to be fully charged each day.
- Mobile devices not issued by NCS are not allowed to be used during the school day.
- Mobile devices are assigned a unique serial number that is attached to each student's record.
- Students will take proper care of their assigned device and agree to not eat or drink while using the device, and to immediately report any accidents or problems.
- Students will be assigned a personalized Google account that is used to manage the device, as well as allow access to student-specific content, settings, applications and storage space for documents.
- Your mobile device is intended to be used as an academic tool to enrich the learning environment at NCS. Students are expected to use responsible, safe, and respectful practices at all times when using the mobile device. The act of bullying, harassment, embarrassment and/or harm toward another person will not be tolerated and will be subject to appropriate disciplinary and/or legal actions.
- Mobile devices are only to be used for educational purposes, including games.

If loss or damage occurs, students and their parent or guardian agree to any applicable charges outlined below. The charges are intended to promote good habits and responsible handling of NCS issued mobile devices. Devices reported as stolen outside of school require that parents notify police and send an official police report to their school administration.

Incidents: Full price of repair or replacement for a damaged mobile device and a parent/guardian meeting with administrator required. Charge of \$300 for lost or stolen mobile device (off campus) and a parent/guardian meeting with administrator will be required. A charge of \$25 is required for lost, stolen or damaged AC adapter. Multiple incidences of damage may result in loss of right to use the mobile device.

No Right or Expectation of Privacy in Using District Equipment

Users have no right to, nor should they have any expectation of, privacy while using any school owned device.
